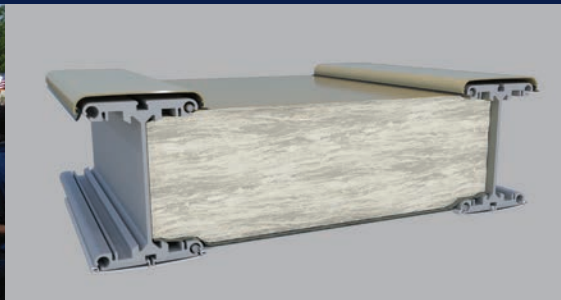

Prison overcrowding at Mecklenburg County had become so severe that sometimes up to 300 prisoners slept on the floor. Officials visited 2 correctional sites in Florida already using Sprung Structures to house inmates. They determined that Sprung offered a fast, cost effective solution that met their needs, and were able to complete construction in half the time of traditional building methods.

Eight 50' wide x 110' long

After the devastating consequences of Hurricane Katrina in 2005, the Orleans Parish Sheriff's Department had to immediately replace correctional facilities that could match the amenities of their traditional building. The temporary jail also had to fit in a confined parking lot space. Orleans Parish turned to Sprung Structures to meet their needs. Each structure can house 100 inmates and are fully insulated, climate controlled and equipped with sprinkler systems.

The structures have an unparalleled clear-span interior, accommodating such necessities as guard towers, while simultaneously maintaining the open layout for security purposes. The power generators and HVAC units are all elevated for long-term planning in the event another massive flood strikes the area.

El Paso County Community
Detoxification Facility
Two 70' wide x 160' long

El Paso County selected Sprung as the product of choice for their facility due in part to the engineered clear span design of the structure, energy efficient insulation system as well as a dramatically accelerated construction time line that would bring the facility online within a 5 month period.

The Detoxification Facility is designed to help clients find more in-depth help when they are ready to change their lives. The projected average stay for clients is between 12 to 72 hours, but a court appointed stay could be longer. The interior includes an attorney office for clients that feel they need legal assistance, an assessment center, classrooms, beds and tables for dining. Clients either go to the detoxification facility of their own will, are dropped off by authorities, or are sent by the courts.
